



1 That our Trust is of non-proprietary character in terms of our trust dated 26/06/2010 which specifically prohibits the application of income of trust to the trustees in the form of dividend or distributions in any form under any circumstances .

2 That Global City Educational Trust, having its Registered office at #135, 5<sup>th</sup> Main, 6<sup>th</sup> Cross, MalleshPalya, Bangalore – 560 075(Name of the Society/Trust/Company under section 8) is of Non-Proprietary Character.

3 That Global City International School is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.

4 That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The savings if any, after meeting the recurring and nonrecurring expenditure and contributions to developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.

5 That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.

6 That the school will not open classes under CBSE pattern for classes XI/XII and will not use CBSE name in any manner without obtaining affiliation.

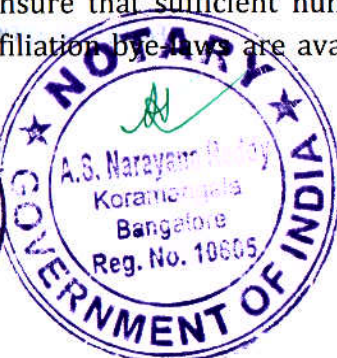
